A first step towards Central and Eastern Europe markets

Autogrill moves into Slovenia and opens seven new motorway F&B locations under an agreement with OMV

- The 20-year contract will generate accumulated sales of €200m.

- The first three F&B location scheduled to open in December 2005.

Milan, 28th October 2005 - Autogrill S.p.A. (Milan: AGL.MI) and OMV Slovenija d.o.o. have signed a contract to build and develop seven large F&B outlets in service areas along motorways in Slovenia.

OMV Slovenija, a subsidiary of the Austrian multinational OMV A.G., is the no. 2 fuel distributor on the Slovenian road network.

The 20-year contract will generate overall revenues of €200m.

The Slovenian motorway network (two intersecting axes) has substantial development potential and will be extended to 500 km within two years. In particular, the East-West axis will form a significant portion of the so-called "Corridor 5" and constitute the main gateway towards other EU and non-EU countries.

The seven service areas, of which some will be of new construction, will be located alongside petrol stations.

The first three F&B locations will be opened by the end of December, in Lukovica (Lubiana) and Dobrenje East and West (Maribor).

The F&B offering will be a mix focusing on local products as well as premium Italian foods. Autogrill will be marketing some of its best-known brands, such as Acafé, Spizzico and Aldente.

OMV Slovenija, trade in oil products, Ltd.

With corporate seat in Koper, OMV Slovenija is a subsidiary company of the OMV Adriatic Holding Ltd., which since October 2004 is a wholly-owned subsidiary of OMV Refining & Marketing GmbH. OMV Slovenia performs the trade with oil products on the territory of Slovenia. In its retail network, the company disposes of 102 dealer-operated filling stations which besides offering to mobile customers a high quality fuel, entirely in line with the EU standards, are constantly upgrading the

quality level of all products and services. In the field of wholesale, OMV Slovenia is active in the field of heating oil and lubes sales to large Slovenia customers.

OMV Aktiengesellschaft

With Group sales of €9.88b and a workforce of 6,475 employees in 2004, as well as market capitalization of approx. €14b, OMV Aktiengesellschaft is Austria's largest listed industrial company. As the leading oil and gas group in Central Europe, OMV is active in Refining and Marketing (R&M) in 13 countries and has set the goal to increase its market share to 20% by 2010. In Exploration and Production (E&P) OMV is active in 17 countries on five continents. In the Gas business segment OMV has storage facilities and a 2,000 km long pipeline system, transporting 43 bcm of natural gas annually to countries such as Germany and Italy. OMV holds stakes in integrated chemical and petrochemical plants – 50% in AMI Agrolinz International GmbH and 35% stake in Borealis A/S, one of the world's leading producers of polyolefin. Other important holdings are: 51% of Petrom SA, 50% of EconGas GmbH, 45% of the BAYERNOIL refining network and 10% of the Hungarian company MOL.
